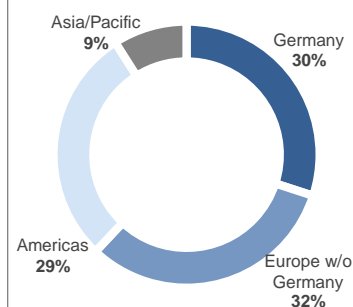

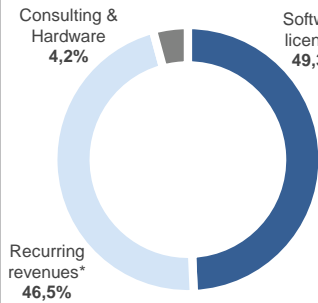

53.1% by Family Nemetschek; 46.9% Free float

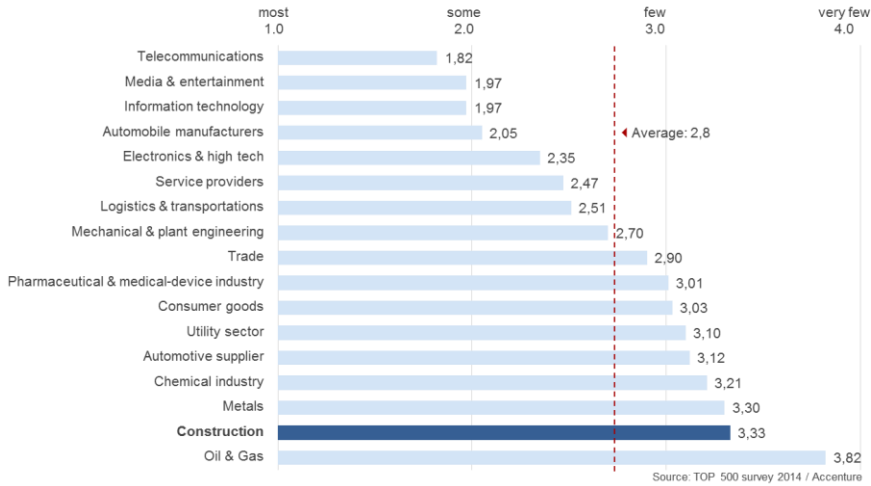

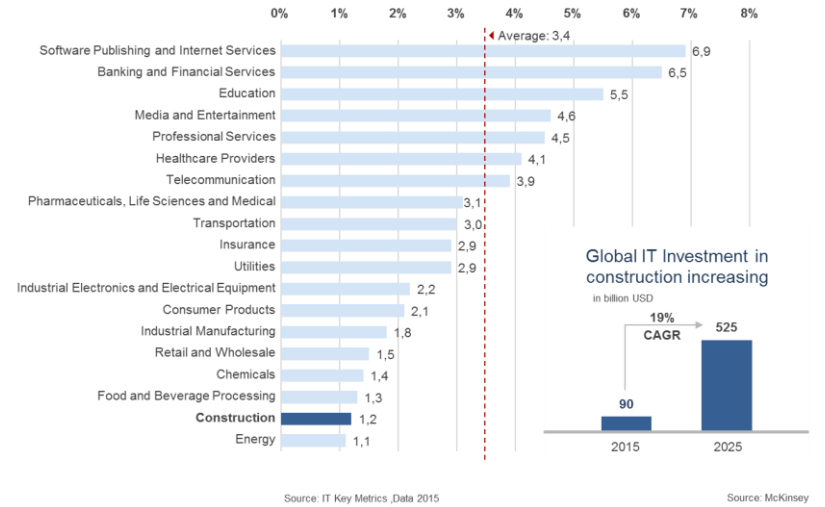

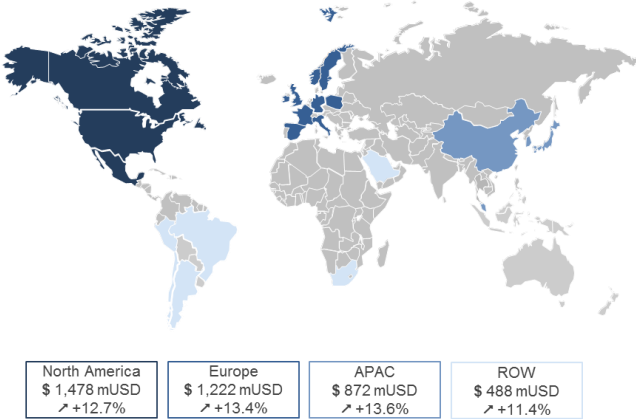
Mega Trend Digitalization – Entering The Industries



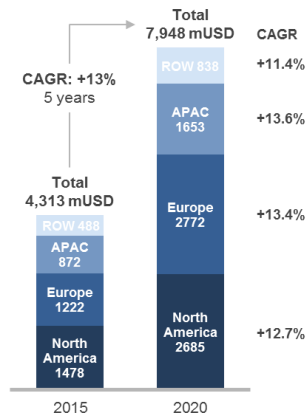
IT Spending as a % of Revenue by Industry (2015)



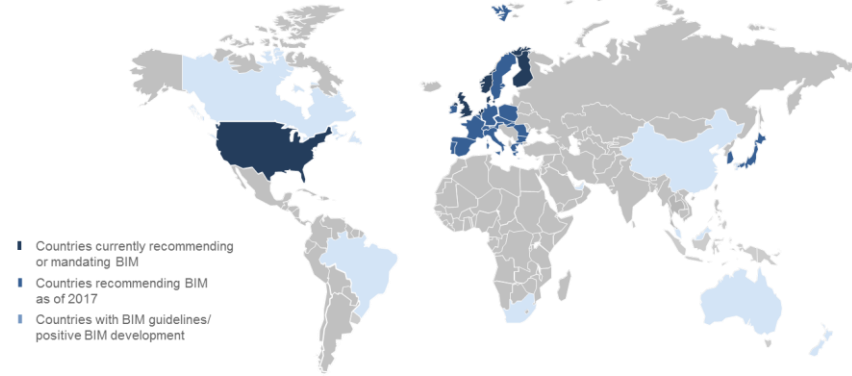
BIM Market by Region 2015
